is seeking to purchase a piece of original indigenous artwork that will be the result of a competition. This artwork will be by an Aboriginal Artist/s of the Gunditjmarara.

The first prize winner's original artwork will be utilised as the indigenous visual identifier of the organisations within the GROW committee.

The four runners up artworks will be reproduced up to ten times to be on permanent display in each of the health services that make up GROW, along with the winning artwork.

The artwork is to reflect the core business of health and each organisation's respect for our Aboriginal and/or Torres Strait Islander community and our commitment to support and empower the health journey for all people, especially those in South West Victoria.

The core business of the committee is about health and wellbeing which involves traditional owner's and Torres Strait Islander's guidance, to include learning from each other and building and expanding health services within the region.

The selected artists will receive prizemoney for the purchase and licencing agreement for the exclusive use of the artwork.

This image should portray the organisations and committee respect for Aboriginal and/or Torres Strait Islander people and our commitment to support, empower and campaign for all people.

The artwork will also be displayed within the organisations to assist in creating a culturally safe and welcoming environment that is sensitive to the cultural needs of its Aboriginal workforce and community.

The artwork or parts thereof will be used by each of the health organisations listed for use in written and electronic documents and displays, pamphlets, identification nametags and other documents, including electronic displays related to the documents, to be a visual identifier the GROW committee and to highlight health for all people.

Prize money to be payment for purchase and licencing agreement for 10 years of exclusive use of artwork and story.

First prize \$1,600

Runners up x 4 of \$250 each for rights to reproduce the artwork and story up to ten times for display in each member of GROW's organisation.

The invitation is open to both emerging and established Gunditjmara Aboriginal artists.

General

1. The competition is conducted by the Grow Healthy Together Indigenous Advisory Committee.
2. The Grow committee reserves the right to extend, cancel or amend the process for the selection panel, including these Terms and Conditions at any time.

Who can enter

3. Entry is open to all Gunditjmarra artists

How to Enter

4. The competition is now open and closes at 4pm Friday 23 June, 2017.
5. It is a condition of entering the competition that the entrant agrees to and signs the Terms and Conditions that are outlined.
6. All entries must:
 - Be the original work of the individual entrant
 - Be a two dimensional piece 'painting or drawing' (not digital imagery)
 - Not exceed 1.5 metre x 1.5 metre in size
 - Be no smaller than 60cm x 90cm
 - Be capable of digitisation and
 - Has not been used previously in any other display or publication
 - To submit an entry into the competition, a hard copy of the entry form must be signed and attached to the artwork and submitted to:

- Entrants are responsible for the costs of delivering the entry to Portland District Health
- All entries that are not deemed eligible for prize winners will be available for pick up after the announcement of the winners. Entrants are responsible for any costs of delivering this artwork.
7. Only valid entries received before the closing date will be considered

8. The GROW Committee reserves the right at any time to verify the validity of entrants (including an entrant's identity and place of residence)
9. A selection panel consisting of the members of the Grow committee will be convened for the purposes of determining the winning entries
10. The decision of the Selection Panel in relation to the shortlisting of entries, the selection of the winners, or any other aspect of voting for the competition is final and no correspondence will be entered into.

Intellectual Property

11. The successful selected artist will hereby enter into an intellectual property agreement, agree to the terms and conditions set out in this document and agree to having their artwork and the story of the artwork purchased and a licencing agreement for 10 years of exclusive use of artwork used in full or part thereof for the purpose of the following:
 - Use by the organisations within the GROW committee to use in written and electronic documents and displays, pamphlets, identification nametags and other documents, including electronic displays related to the documents.
 - Use the imagery to highlight health for all people
 - Visual identifier for the GROW committee
12. The successful artist and 4 x Runners up artists agree to having their artwork and story of their artwork reproduced up to 10 times for display in each member of GROW's organisation.
13. The GROW committee and the included organisations:
 - Will include attribution of the winners as the creator of the entry by the insertion of the following wording on all reproductions, of any part of the artwork where, in the absolute discretion of the organisations, it is reasonable to do so: 'Copyright © This artwork is reproduced with the permission of the artist, and
 - Will not use the artwork in a manner that is prejudicial to or detrimental to the honour or reputation of the artist.

Rights of the GROW committee and health organisations listed:

14. The organisations are not liable for any loss or damage whatsoever which is suffered by any entrant, including, but not limited to, indirect or consequential loss, or for personal injury suffered or sustained during the course of entering the competition or acceptance of a prize, except for any liability which cannot be excluded by law.
